# **Proposed User Charge Rate Decrease**

### **Proposed Sewer Service Increase**

#### **CURRENT**

- 1) Operation and maintenance rate schedule.
  - a) User Charge: \$30.09 per month/includes first 1,000 gallons
  - b) Sewer Service Charge: \$1.79 per 1,000 gallons
- 2) Finance charge rate schedule.
  - a) User Charge \$4.60 per month
  - b) Service charge \$0.45 per 1,000 gallons

For residential contributors, monthly user charges will be based on average monthly water usage during the months of January, February, and March. For industrial and commercial contributors, user charges shall be based on water used during the current month.

#### **PROPOSED**

- 1) Operation and maintenance rate schedule.
  - c) User Charge: \$24.50 per month/includes first 1,000 gallons
  - d) Sewer Service Charge: \$1.90 per 1,000 gallons
- 2) Finance charge rate schedule.
  - a) User Charge \$4.60 per month
  - b) Service charge \$0.50 per 1,000 gallons

For all sewer contributors user charges shall be based on water used during the current month.

The Sewer rates for the City of Cole Camp, Missouri, if approved will be effective for billings on or after the 30<sup>th</sup> day of April, 2023.
